**IN THE MATTER OF** an application by Coach Atlantic Transportation Group Inc. for approval of Routes, Schedules and Fares for its inter-city scheduled services within the Province of New Brunswick.

### **ORDER**


Pursuant to a decision of the Board in Matter 561 dated October 27, 2023, Coach Atlantic Transportation Group Inc. ("Coach Atlantic") received approval to vary the fuel surcharge to passenger fares for its inter-city motor coach service. This fuel surcharge is reviewed by the Board on a quarterly basis. In accordance with the amended fuel surcharge methodology previously approved by the Board, the Board finds:

1. The average New York Harbour spot price for ultra-low sulphur diesel fuel ("ULSD") for the period January 1, 2010, through June 30, 2010 (the "Base Price") was 59.3 cents per litre.
2. The average New York Harbour daily spot price for ULSD for the period April 1, 2025, through June 30, 2025, was 80.15 cents per litre, the federal fuel charge for ULSD is 0.0 cents per litre and the average cost of carbon adjustor for the period was 4.14 cents per litre. This results in an average cost of ULSD of 80.15 cents per litre, which is a 20.85 cent per litre increase in the cost of ULSD versus the Base Price.
3. The fuel surcharge methodology permits Coach Atlantic to assess a fuel surcharge to passenger fares of 0.5 % for each 2.5 cent incremental increase in the price of ULSD over the base price.
4. Accordingly, the fuel surcharge methodology results in a fuel surcharge of 4.5 %.

Effective July 15, 2025, until further order of the Board, the fuel surcharge is set at 4.5% for all passenger fares for inter-city motor coach service provided by Coach Atlantic. The approved schedule of fares, incorporating the current surcharge, is attached as Schedule A.
