**O R D E R**

**WHEREAS** in relation with the filing of its additional evidence, NB Power filed a Claim for Confidentiality under Rule 6.4, dated October 31, 2025, with respect to portions of two documents;

**AND WHEREAS** the said Claim for Confidentiality set out the particulars of the affected documents, the details of the proposed confidential treatment in this proceeding and the rationale for the claim of confidentiality;

**AND WHEREAS** the Board received a Notice of Objection to the said claim from Dr. Andrew G. Secord dated November 25, 2025;

**AND WHEREAS** after a public hearing held on November 28, 2025 and upon its own review of the materials over which the claim for confidentiality is sought, the bases for such treatment and the proposed treatment of those materials in this proceeding, the Board is satisfied that the claim for confidentiality and the proposed treatment is necessary and appropriate;

**AND UPON HEARING** John G. Fury, counsel for the Applicant, NB Power and Dr. Andrew G. Secord, Intervener in this proceeding;


**IT IS ORDERED THAT:**
